FOR OUR MAJESTIC WIDOW MEMBERS**

My name is PDGC Steve Wandy and I am the Financial Secretary of the Majestic Benevolent Association. I can be reached at (718) 668-2790. I am responsible for sending out the dues notices for the widows of former Majestic Lodge brothers (also Challenger and Excelsior lodges if you remember those names). Anyway, there are a few things I wanted to make our widow members aware of.

1) First, as our widows pay dues based on a calendar year, the bills for 2025 will be put into the mail sometime in December.

2) Second, as the bills indicate, I need the checks in payment of your dues made payable to "MAJESTIC BENEVOLENT ASSOCIATION", not MAJESTIC LODGE or my name. This is a business checking account and if the checks are not made payable properly, I have had issues depositing your checks. Thank you.

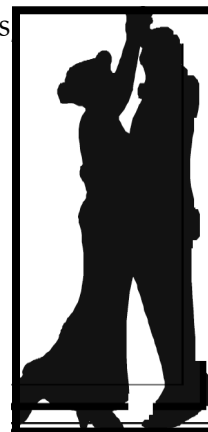

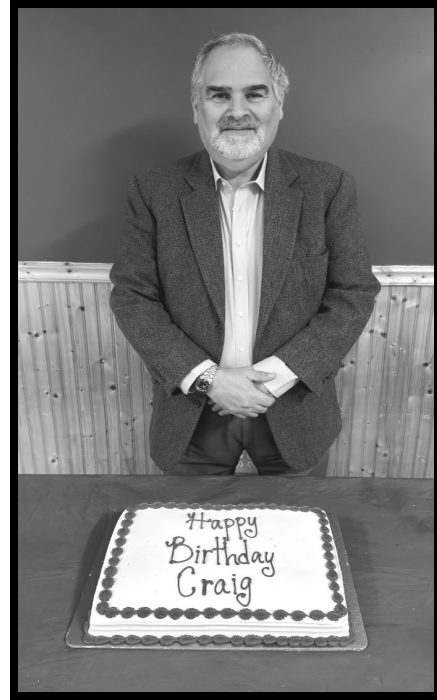

## Pythian Scholarships Available

The Grand Lodge has scholarships available for the children of Pythians. In order to obtain an application, you must call the Grand Lodge Office (Monday - Thursday 10 AM - 3 PM). For those seeking scholarships for the fall of 2025 the following rules and regulations apply:

1. The scholarship awards will be up to \$4,000.00, payable over a four-year period based upon funds available that year.
2. Two-year colleges will be recognized. The award will be reduced pro-rata.
3. College must be accredited by Middle States Association of Schools and Colleges or equivalent accreditation association.
4. A sponsor must be a member in good standing for at least two years before being eligible to apply for a scholarship and must remain a member for at least the duration of the scholarship period. In addition, the member's home lodge must be in New York State.
5. The widow of a deceased Pythian would be eligible to receive a scholarship for her child if the deceased spouse was a member in good standing at the date of his death and she has not remarried.
6. Only one child per family is able to receive a scholarship at any one time.

The eligibility requirements are:

1. A minimum average of 85%
2. Parents income not in excess of \$250,000
3. Sponsor must be a paid up member of his lodge
4. A completed application as per instructions sent with the application

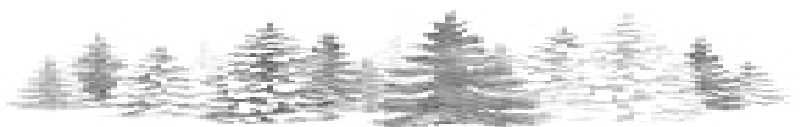
